- participation in coordination meetings at the construction site within the time limits set by the investor;
- verification of the documents necessary for the submission of an application for permission for use by the investor;
- checking the calculation of additional works, substitute or abandoned works;
- supervising compliance with fire and safety regulations at the site of investment;
- participating in technical testing and commissioning of installations, technical equipment and archiving all protocols of tests carried out during construction;
- indication of defects made by the designer or erection contractor during work and final acceptance;
- preparation of materials related to the calculation of contractual penalties;
- financial settlement of investment;
